

# CAMPSITE RULES

**ADMISSION CONDITIONS :** To be allowed to enter the campsite, one must have been authorized by the manager. Anyone staying at least one night in the camp must present their identification documents to the manager beforehand. Only persons who can provide proof of a fixed residence are allowed on the premises.

**INSTALLATION:** The tent, caravan, motorhome... and all the equipment must be set up at the location indicated by the campsite manager.

**FACILITY :** Tent or caravan and equipment must be installed on pitch specified by manager

**RECEPTION DESK:** Open 8 AM to 12 PM and from 1 PM to 7 PM (8 PM in July-August)

**FEES:** They are paid at the office. Camp users are requested to inform the office the day before their departure and to settle if they leave before the office opens.

**CAMP LIFE:** Camp users are asked to avoid all noise or discussions that may disturb their neighbors. Sound devices must be adjusted accordingly. **Silence must be maintained between 10 PM and 7 AM.** Dogs and other animals must never be left loose, must be kept on a leash. Under no circumstances should they be left alone on the campsite, even if confined, in the absence of their owner, who is civilly responsible for them. Dogs of categories 1&2 are not accepted in the camping area.

**VISITORS:** Subject to the approval of management, visitors may be admitted to the campground – except at the pool – under the responsibility of the campers who host them. If the visit lasts more than 2 hours, they are required to pay a fee.

**CIRCULATION AND PARKING:** The speed limit is set at 10 km/h. Between 10 PM and 7 AM, all traffic is prohibited. After 10 PM, parking is in the designated parking area. Only vehicles belonging to campers staying there are allowed to circulate.

**CONDITION AND APPEARANCE OF THE FACILITIES:** Everyone is required to refrain from any action that could harm the cleanliness, hygiene, and appearance of the camp. Plantings and floral decorations must be respected. Any damage will be the responsibility of its author. It is not permitted to dig the ground or mark locations, or to cut tree branches.

**BARBECUES:** Only gas or electric barbecues and grills are allowed; those using wood or charcoal are prohibited.

**ELECTRIC VEHICLE CHARGING:** **For safety reasons, it is strictly forbidden to charge your vehicle in the campsite area, as it could endanger all residents of the campsite.**

**VOL, LOSS :** Of whatever nature it may be, during or following the stay, the campsite's liability is not engaged. The establishment is under video surveillance; please report the possible presence of any suspicious person.
